## 2010 Legislative Session

The 2010 session of the WV state legislature kicked off on January 13, 2010. A highlight of the items on Governor Manchin's agenda is contained herein. In addition, attachments to the newsletter will be provided to our members so that more detailed information can be referenced. If there are any items on that you would like to have brought to the attention of our elected representatives, please let me know as I have established a dialogue with those that represent Jackson County.

Items of note that are on the agenda include tax reform, judicial reform, better management of the state's vehicle fleet, educational system changes, and how to weather the economic storm during what is projected to be a very slow recovery from the worldwide recession.

When it comes to the area of tax reform, Gov. Manchin would like to pass a "constitutional amendment that will give us the flexibility we need to lower taxes on commercial and industrial property, while also considering the impact on local governments." This is an item that we will watch closely in Jackson County. Lower taxes are an incentive for businesses to locate in West Virginia and can allow for businesses to invest more in themselves. However, the removal of ad

In the Ripley area several changes have been seen. One such example is the new Holiday Inn Express that is located behind the old Wal-Mart. This facility has 72 rooms for overnight accommodations, an indoor pool, exercise area, business center, conference room, and a welcoming area. This new hotel will be another asset and allow for our area to be a better draw to host future events.

On January 19<sup>th</sup> Hog Heaven BBQ opened across from the courthouse at 204 W. Main Street. valorem taxes could negatively impact the services that the Jackson County Commission provides to the county unless the state allocates additional funding to the county. This bill may prove to be the most significant for Jackson County and will constantly be monitored throughout the session.

Judicial reform is another area that everybody will be watching. Year after year our state ranks at or near the bottom in terms of our legal climate. Whether this is actually the case or not, it is the perception that businesses have when evaluating West Virginia as a potential site to locate. Changes with the state's appellate process look to be on the horizon, which would be a step in the right direction.

Governor Manchin wants to overhaul the way that the management of the state's vehicle fleet is handled. Audits have highlighted flaws within the current system that must be addressed. One revelation is that personal use of vehicles within the state fleet needs a better monitoring system. No one really knows how pervasive a problem this may be, but the state spent \$24 million on fuel in 2008. In addition, changes to how the vehicle maintenance program is managed could offer significant savings. A few years ago the state of Virginia addressed similar questions, and the changes that they have made could serve as a model for our state.

Changes with the educational system are forthcoming to make it easier for schools to meet the mandatory 180 days of instruction for students. The severe weather conditions this year put many school systems at risk for not being able to meet these guidelines. Removing the dates when students may attend class will allow all our school systems to provide the classroom instruction that our students across the state deserve.

Lastly, Gov. Manchin has stressed the need for a reduction in budget without tapping into the Rainy Day Fund. West Virginia has taken careful measures to not overextend its resources as some other states did prior to the recession. There have been no furloughs of state employees or moves to a 4-day workweek. No raises are being discussed this year as there simply isn't the money in the budget to accommodate such a proposal. The impact of the EPA on mining permits is something that will be closely monitored. If mines are idled because of increased regulatory scrutiny, then jobs will be lost and the coal severance tax that the state collects will drop.

Overall, this session of the state legislature is a bit lighter than ones in the past. With that being said, items on the agenda will shape the future of the state. Reform in certain areas will hopefully change negative perceptions of West Virginia. Momentum that we have gained from previous

legislative reform, such as that with the workers compensation system, must continue. As mentioned earlier, I have met with the delegates and senators that represent our county, and I would be happy to pass along any concerns that you have. As the session moves into full swing, I will update everyone on any major developments.

## **West Virginia Chamber Hosts Legislative Briefing Sessions**

The West Virginia Chamber will host several briefing sessions that focus on some of the main topics that are on this session of the 79<sup>th</sup> WV Legislature. The first session on January 19<sup>th</sup> brought two members from the Office of Governor Joe Manchin. Mr. Jim Spears, the Chief of Staff, and Jim Pitrolo, the Legislative Director were on hand to discuss the agenda and take questions. They offered detailed insight into some agenda items. One item that Mr. Pitrolo discussed was the proposed constitutional amendment that would allow for changes in the way that ad valorem taxes are handled. After listening to him I believe that any changes that are made will be weighed heavily, and that they will not be made without helping to offset the revenues that counties will lose.
